### FTA Public Transportation COVID-19 Research Demonstration Grant



#### What is eVoucher?

- Electronic and contactless payment system for driver reimbursement
- Primarily for Human Service Agencies to pay for trips for their clients
  - Historically these trips are made using volunteer drivers
  - Payments to these drivers can take weeks to process
- Eliminates the need for paper voucher payment systems
  - Paper systems have little to no way of verifying trips
  - Greatly reduces the potential for waste, fraud, and abuse
- Common need across the country
- Benefits both urban and rural areas
- There is no commercial product that fits this need



#### **eVoucher Federal Grant Awards**

- May 2019 \$700,125 from the FTA Innovative Coordinated Access and Mobility Grant for development of Phase 1 of the eVoucher system
- January 2021 \$508,200 from the COVID-19 Research Demonstration Grant Program for Phase 2 of the eVoucher system
- Total Federal awards = \$1,208,325



#### **Phase 1 Development**

- Focused on volunteer driver programs
- Agency web application
- Driver mobile application
- Electronic payment to drivers
- Trip verification using mobile technology
- Can be used for any voucher program across the country



#### **Phase 2 Enhancements**

- To facilitate a purchase of a UTA mobile ticket
- To facilitate a purchase of a TNC fare, such as Uber, Lyft or Taxi
- Creating a web portal and mobile application for clients
- Other identified enhancements
